- Home/Business built prior to 1995 or toilet installed prior to 1995 and 3.5 gallons per flush
- High efficiency urinals available for rebate for commercial properties
- Newly installed residential toilets must be 1.28 gallons per flush

Must have utility services provided by City of Venice to qualify



REMINDERS:

- Newly installed commercial toilets must be 1.6 gallons per flush
- Newly installed commercial urinals must be 0.5 gallons per flush
- Up to \$100 rebate for 1st toilet and up to \$80 for 2nd toilet

City of Venice Toilet Rebate Application

INSTRUCTIONS:

1. Request an application from the Utilities Department at (941) 882-7310 or smckenzie@venicefl.gov
2. Complete this application and return it to the program administrator along with your **original sales receipt AND** pictures of both old and new toilet lid and tank (inside and outside if possible), and a picture of new toilet installed (total of 5 pictures AND receipt). Application, receipt and pictures can be mailed, emailed or dropped off at the address below.
3. After your application has been processed, the program administrator will contact you to informing you if an on-site inspection will be required. If no on-site inspection is required, the program administrator will inform you at that time the old lid can be disposed of. This will be your responsibility.

Please note this program is available only to residential customers and business owners of the City of Venice whose home or business was built prior to 1995 or toilet installed prior to 1995 and toilet was 3.5 gallons per flush.

- 6) All toilets for which a rebate is applied must be verified by a photograph of the toilet after installation, showing no obvious leaks or deficiencies.

By signing below, I am confirming the following:

- 1) New toilet shows no evidence of leakage
- 2) New toilet has been confirmed to be operating properly
- 3) Water level in the new tank and bowl are consistent with the manufacturing standards
- 4) Low efficiency toilet (3.5gpf) has been replaced by a high efficiency toilet (1.28gpf) for residential accounts and an ultra-low flow toilet (1.6gpf) for commercial accounts; low efficiency urinal (1.5gpf) replaced with high-efficiency urinal (0.5gpf) for commercial accounts
