

## **Business Impact Estimate**

**Proposed Ordinance Title:** Ordinance No. 2024-21: An Ordinance of the City of Venice, Florida, Amending the Code of Ordinances, Chapter 62, Streets, Sidewalks, and Other Public Places, Article II, Sidewalks, Section 62-31, Duty to Maintain Sidewalks and Area Between Sidewalk and Curb; Providing for Repeal of All Ordinances in Conflict Herewith; Providing for Severability; and Providing an Effective Date

In accordance with the provisions of controlling law, even notwithstanding the fact that an exemption noted above may apply, the City of Venice hereby publishes the following information:

- An estimate of the direct economic impact of the proposed ordinance on private, for-profit
  businesses in the City of Venice, if any: Proposed Ordinance 2024-21 will only affect the adjacent
  property owner in the event the property owner fails to perform the necessary maintenance as
  required to protect the health, safety, and welfare of the citizens and visitors of the City of
  Venice.
  - a. An estimate of direct compliance costs that the businesses may reasonably incur: If the property owner fails to maintain the sidewalk section within their driveway, the city will complete the work and bill costs to the adjacent property owner.
  - b. Any new charge or fee imposed by the proposed ordinance for which businesses would be financially responsible: Ordinance 2024-21 does not increase the financial responsibility since that is already required in existing Section 62-31.
  - c. An estimate of the City of Venice's regulatory costs, including estimated revenues from any new charges or fees to cover such costs: Revenue will directly offset costs incurred by the City.
- 2. Good faith estimate of the number of businesses likely to be impacted by the proposed ordinance: Proposed Ordinance 2024-21 will likely impact very few business as most already complete their maintenance activities on schedule.
