

**ORDINANCE NO. 2018-06**

**AN ORDINANCE AMENDING CITY OF VENICE ORDINANCE NO. 2017-31 WHICH ADOPTED THE OFFICIAL BUDGET OF THE CITY OF VENICE, FLORIDA FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2017 AND ENDING SEPTEMBER 30, 2018; BY INCREASING THE TOTAL REVENUE BY \$1,821,695 AND TOTAL EXPENDITURES BY \$1,821,695; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the City of Venice, pursuant to Section 200.065, Florida Statutes, adopted its Operating Budget, Revenues and Expenditures, and Capital Improvement Program for Fiscal Year 2018 by approving Ordinance No. 2017-31 on September 27, 2017, said budget being \$122,387,531; and

**WHEREAS**, the City of Venice increased said Operating Budget by the amounts of certain commitments for purchases (i.e., encumbrances) and projects, totaling \$20,801,575 and \$5,997,202 respectively, up to an "Adjusted Original Budget" amount of \$149,186,308; and

**WHEREAS**, the City of Venice desires to amend its Operating Budget, Revenues and Expenditures, and Capital Improvement Program for the Fiscal Year 2018 by increasing the total revenue and total expenditures by \$1,821,695 as detailed in Exhibit "A", attached hereto; and

**WHEREAS**, of the revenue needed to cover increased expenditures, \$78,655 comes from General Fund Reserves, \$25,900 comes from Grant Funds, \$42,000 comes from the Streets Capital Projects Fund Reserves, \$1,333,749 comes from the Water and Sewer Utility Fund Reserves, \$338,428 comes from the Stormwater Fund Reserves, and \$2,964 comes from the Fleet Replacement Fund Reserves.

**WHEREAS**, this amendment is authorized by Section 166.241(4), Florida Statutes.

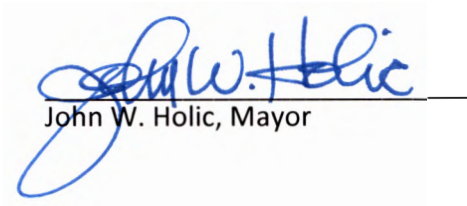
**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF VENICE, FLORIDA:**

**SECTION 1.** Ordinance No. 2017-31 which adopted the City of Venice Operating Budget, Revenues and Expenditures, and Capital Improvement Program for the Fiscal Year 2018 is hereby amended as detailed in Attachment "A," which is attached hereto and incorporated herein by reference.

**SECTION 2.** This Ordinance shall become effective immediately upon its approval and adoption, as provided by law.

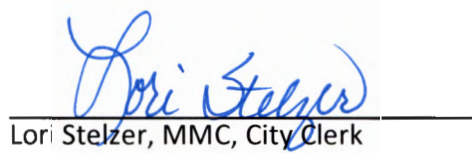

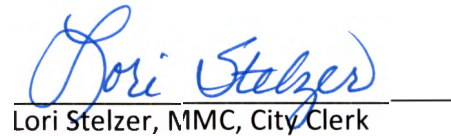

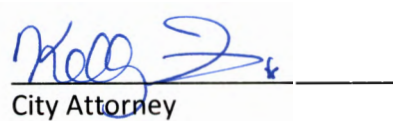
